The sidewalks would provide safe connections to Conejo Elementary School, Colina Middle School, transit stops of both Hillcrest Drive and TOB, and connection to businesses on TOB. Students currently walk on a two-lane road with a limited dirt shoulder that is posted 25 m.p.h., has multiple driveways (30+), and has substandard curves. It is difficult to see pedestrians as vehicles travel around the turns in the road. There are also many (30+) driveways, including Conejo Elementary School, the Conejo Recreation and Park District Maintenance and Facilities Yard, the First Church of Christ, the Elk's Club, and several apartment buildings. A combination of these uses and single-family homes generate a need to protect the pedestrians from daily traffic; at the same time a new sidewalk will also "connect" these uses.

A new sidewalk and curb ramps on Conejo School Road will provide an important piece for the walking route to school. Because this is a "missing link" or "infill" sidewalk, there are already many students who use this route and the new sidewalk will make it safer and encourage new pedestrians to walk these routes. The paved sidewalk will become a pedestrian lane that provides a buffer from the travel-way. Most importantly, it will provide a safe accessible area for pedestrians with disabilities. The new sidewalk will help "elevate" the students because the sidewalk is at a minimum 6 inches above the street. This can make the difference of someone being under 5 feet to being over 5 feet, which makes

the drivers see them more easily. It also keeps them out of the intersection when approaching a cross street. The pedestrians have better sight distance to cross the street and the drivers can see them better.

City collision data indicates that there were 43 reported collisions on Conejo School Road between TOB and Hillcrest Drive in the past 10 years (January 2006 – January 2016). Of the 42 collisions, 13 were injury collisions. Ten collisions occurred during school "walking" times (7:30-8:30 a.m. and 2:30-4:30 p.m.). Two of the reported collisions involved pedestrians. Based on the data, it is not possible to provide a correlation between constructing a new sidewalk and correcting the accident patterns. It is possible to conclude that providing a path for pedestrians off of the roadway will keep them out of the way of future accidents.

The City will maintain the sidewalk as part of its annual sidewalk maintenance program. Funding for sidewalk maintenance has been budgeted in the City's Capital Improvement Program.

The construction of a new sidewalk on Conejo School Road between Thousand Oaks Blvd.-Hillcrest Drive will provide many connections. On an average day in 2015, there were 499 walkers and 80 bicycle riders on this route.

There is great potential for an increase in walking and bicycling along this corridor as it is a direct connection for students living off TOB and Hillcrest Drive that walk to Conejo Elementary School (CES). It also would become a Safe Route to School route for students walking to Colina Middle School (CMS) that live south of Los Felix Drive and south of TOB. Currently 329 students attend CES, and 1,126 students attend CMS, and with 90% living within one mile of CES, and 20% who attend CMS live in the same neighborhood. Roughly 40% of the students would use this route if the sidewalk were constructed. Additionally, residents who live north of Hillcrest Drive will use the new sidewalk to access Thousand Oaks Blvd. for shopping and services.

The project provides access to City Hall and the Civic Arts Plaza (CAP) which are located at 2100 Thousand Oaks Blvd., next to the Lakes Shopping Center, which features shopping/restaurants, two lakes, a children's playground, pathways, and rose gardens. Directly across the street from the CAP is the Gardens of the World. The Gardens are open to the public and commemorate the various cultures of the world. TOB is a major employment and entertainment corridor. City Hall and the CAP are located1/4-mile east of the intersection of Erbes Road and TOB, and is directly west of the intersection of Conejo School Drive and TOB. The CAP is the largest performing arts center between Los Angeles and San Francisco with two stages (1,800 seats and 394 seats); over 300,000 patrons and 50,000 children attend more than 400 performances annually. In addition to City services provided at City Hall, the City Clerk's department houses the Ventura County Clerk Satellite office which provides passport processing and marriage licenses.

The sidewalk project will provide greater access to the two bus lines (TOT Red and Blue lines) that service the Ventura County Human Services Agency's "Under One

Roof." This office provides services for applying for Medi-Cal, Food stamps, and Cal-Works, in addition to a dozen nonprofit organizations dedicated to helping those in need. Bus stops for these two routes are located in front of CAP/Gardens of the World and on Hillcrest Drive/Erbes Road. Access to these bus stop are within ½-mile from all four projects.

Pedestrian and bicycle projects that provide access to schools receive the highest ranking in both the City's "Sidewalk Implementation Plan" and the "Bicycle Master Plan". This project is the only project included in both Plans. Construction for new sidewalks is dependent on available grant funding. If grant funding is awarded to this project, then design will begin in Fall 2016 and construction in Fall 2017.

Past Article 3 funds have all been spent.

Technically, the project could be divided into two phases. Phase 1 would be the section between TOB and Los Feliz Drive; Phase 2 would be the section between Los Feliz Drive and Hillcrest Drive. The cost to construct Phase 1 is estimated at \$360,000. The cost to construct Phase 2 is \$226,000. If the project were broken in to two phases, then there would be an additional cost for mobilization, separate surveys etc., resulting in an additional costs of \$31,000.

The project is located on City streets within the City of Thousand Oaks. The Conejo Valley Unified School District is involved in the project and has offered "inkind" support via the use of the school for community meetings.

The project will connect to the existing sidewalks on Conejo School Road and Los Feliz Drive and provide a connection to existing bike lanes. Conejo School Road is identified on the City's Bicycle Master Plan and extends both north of Hillcrest Drive and south of TOB. Los Feliz Drive Sidewalk project will be complete by the end of April 2016. The new sidewalk on Los Feliz Drive directly connect to this proposed sidewalk project on Conejo School Road.

The construction of the sidewalks will fill in a "missing link" by providing a path for pedestrians, and cyclists will be able to ride on the street without having to share the road with pedestrians. Sidewalks are available on the east side of Conejo School Road, but not contiguously on the west side. The major east/west streets in the vicinity of the project are Hillcrest Drive and TOB. which have sidewalks. This project is the missing link to connect to CES and the major east/west streets in the neighborhood.

A local match of \$445,000 will be provided.

The project will provide an accessible path of travel between TOB and Hillcrest Drive by constructing a sidewalk and curb ramps where there is no sidewalk or curb ramps.

The primary environmental advantage to constructing the sidewalk is to improve drainage along the west side of Conejo School Road. The project would include curbs and gutters which help to channel the rainwater runoff into the adjacent catch basins, which then help to alleviate erosion. More importantly, water on a street can create hydroplaning effects, and can impact the road and safety of travelers. A street drainage system should quickly remove stormwater from the traffic lanes. During a major storm event, street gutters and storm sewers carry the flooding water away.

A community meeting was held at CES on May 16, 2015. The meeting was organized by Ana Alvarez, the Outreach Education Director for CES. 130 parents attended the meeting, and although the focus was not only on pedestrian safety, it was discussed during the first 20 minutes of the meeting. There was overwhelming support for new sidewalk on Conejo School Road, to provide a safe path for their children to walk to school. Cyclists wrote in and expressed their support for bike lanes/sidewalk on Conejo School Road and adjacent streets.

During the development of both the Bicycle Facilities Master Plan and the Sidewalk Facility Master Plan, the public provided input via neighborhood and community meetings, Traffic/Transportation Advisory Commission meetings, and ultimately at City Council. The prioritization of the projects in the plans are a result of the meetings.






CONEJO SCHOOL ROAD – SIDEWALKS, CURB RAMPS AND BIKE LANE PROJECT




Photo's show the unimproved segments on the west side of Conejo School Road starting at Thousand Oaks Blvd.













For a short segment, on the nw corner of Conejo School Rd. and Los Feliz Dr. there is a sidewalk and horse trail.



Police Department, and the City Public Works Department, Park District and Open Space Agency. The BAT is working hard to improve bicycling in the City of Thousand Oaks and meets quarterly.

One of best ways to improve cycling in urban areas is to construct complete sidewalk networks. Sidewalks allows pedestrians to walk safely off the street and provides road pavement free of walkers for vehicle and cyclists to use the lane.
